## THE CONTRIBUTION OF THE ENTREPRENEURS IN SUSTAINABLE DEVELOPMENT GOALS ACHIEVEMENT

Entrepreneurship is increasingly seen as a tool for solving economic, social and environmental problems. Due to the growing recognition of its role in achieving the goals of sustainable development, responsible entrepreneurship is the subject of research in many scientific disciplines. Concepts such as social entrepreneurship, environmental entrepreneurship and sustainable entrepreneurship have emerged in recent decades. The latter is the most comprehensive approach to the problems of sustainable development. Sustainable entrepreneurs aim to achieve many goals and, therefore, integrate economic, social and environmental goals into their organizations.

The aim of the work is to clarify the concept of sustainable entrepreneurship and determine the contribution of entrepreneurs to achieving sustainable development goals.

The UN General Assembly has identified entrepreneurship along with innovation as a key element in addressing sustainable development issues. Resolution 71/221 on entrepreneurship and sustainable development emphasizes the role of entrepreneurship in achieving all three aspects of sustainable development (see Table 1).

Experts consider sustainable entrepreneurship as 1) social entrepreneurship, which aims to achieve non-economic results, such as social effects or welfare, or 2) the creation of social value, capital or satisfaction of social needs. There is also an approach according to which sustainable entrepreneurship must meet three criteria: achieving economic, social and environmental effects. The characteristics of a business organization include innovation, proactivity and risk-taking.

The focus on sustainable development includes all these elements, plus compliance with sustainable development goals. Thus, sustainable entrepreneurship can be defined as proactive, proactive, innovative, systematic, at their own risk economic activity in order to achieve economic, social and environmental results and sustainable development goals.

Sustainable entrepreneurship is analyzed in publications on corporate social responsibility, corporate sustainable entrepreneurship, environmental entrepreneurship, environmental corporate entrepreneurship, green entrepreneurship, macro-entrepreneurship, social entrepreneurship, innovation for sustainable development, sustainable entrepreneurship, sustainable internal entrepreneurship.

Sustainable development and entrepreneurship are studied on the basis of common theoretical approaches, including: the theory of entrepreneurship, dynamic abilities, game theory, institutional and neo-institutional theory, management theory, resource-oriented theory, stakeholder theory.

In more detail, the potential contribution of entrepreneurs in achieving sustainable development goals is given in table 2.

S.L. Hart and M.B. Milstein argues that "in general, innovators and entrepreneurs see sustainable development as one of the greatest business opportunities in the history of commerce."

According to the authors, entrepreneurs have a chance to change their position in the business environment, expanding their competencies to finally turn their industry into one that meets the goals of sustainable development. Among the main benefits of following the principles of sustainable development for entrepreneurs are strengthening the image of a responsible company, creating new market niches or markets, which will contribute to achieving sustainable development goals for society and increase the competitiveness of business structures.

Adherence to the principles of sustainable development creates new opportunities for entrepreneurs to innovate, create new markets and attract additional consumers. Society and humanity as a whole receive positive economic, social and environmental effects due to the increase in the share of products and services offered by entrepreneurs that contribute to the achievement of sustainable development goals. Issues related to the creation of favorable conditions for the development of sustainable entrepreneurship need further study.
